### Formation of Institute Level Anti-Ragging Committee and Anti-Ragging Squad: 2026-2027

In pursuance of the directions of the Hon'ble Apex Court in SLP No. 24295 of 2006 dated 16.05.2007 and Civil Appeal No. 887 of 2009 dated 08.05.2009, and vide AICTE Notification F. No. 337-3/Legal/AICTE/2009 dated 01.07.2009, an Institute Level Anti-Ragging Committee has been constituted with immediate effect to prevent and prohibit ragging on the institution premises.

It shall be the duty of the Anti-Ragging Committee to ensure compliance with the provisions of UGC and AICTE Regulations as well as any law in force concerning ragging, and also to monitor and oversee the performance of the Anti-Ragging Squad in preventing ragging in the institution.
